# **President's Report**



You have spoken and we are responding. Our annual members survey indicated that, while you are satisfied with our current effectiveness in meeting the Council's mission and with our research and publications, you would like to see the Edmonton Social Planning Council have a higher profile in the community and in the media, increase our advocacy activity on emerging issues with elected officials, and involve more volunteers in the Council's work.

I am pleased to report that this year we formalized an Advocacy Board Committee that will help increase our advocacy work and enhance our profile and identity. Our

advocacy activities will always be non-partisan and conform to the Canada Revenue Agency guidelines, and our advice to decision-makers will always be based on research and innovation. Over the year, we have worked with elected officials on developing strategies for dealing with emerging social issues and have also established a network with senior staff in the ministries with whom we meet on an ongoing basis. I am proud to say that we submitted policy strategies to the Minister of Human Services that are closely reflected in the final Social Policy Framework released by the Premier last month. We have also stressed that, jointly with other non-profit organizations, we want to be a full participant in the implementation of the Framework.

We formed an ad hoc Fund Development Committee this year to explore ways to sustain and enhance our funding sources so that we can realize our vision of a healthy, just and inclusive community. We are very pleased with the response we got from donors and volunteers for our awareness event/fashion show, which was held during 2012. Our Finance Committee reported a small surplus this year, which shows that we are using the money we receive in a wise manner. While talking about finances, I want to assure the members that the Finance Committee and the Executive Director have ensured that our expense reimbursement procedures are transparent and in line with practices of other local non-profit agencies.

With the help of law students at the University of Alberta, the Policy Committee meticulously reviewed the Council's bylaws to ensure conformity to the Societies Act and other legislation. The updated and revised bylaws will facilitate our future governance and decision-making.

## President's Report—Cont'd.

Over the years our community has evolved and people's problems and needs have changed; thus the new environment calls for new approaches and new solutions. In 2013 we will be evaluating our past activities and our current role, and moving forward by developing a new vision that involves listening to our membership and partners. We will also hold a retreat for board members and staff. Our strategic plan has completed its three years and is due for renewal in the fall of 2013, and so we have our work cut out for us.

I am pleased to inform the membership of the Council that this year we brought in younger board members with fresh ideas and great enthusiasm to make an impact, and we increased the board's size by three members to respond to its increased undertakings. One member just completed his four-year term, making a valuable contribution, and the Board Development Committee has recruited a new member for the coming year.

Last year saw a lot of changes in the province – the new premier and cabinet, the new official opposition, the province's unsteady fiscal situation, and the ensuing effects on various programs and services. Our Council's role will become even more important in the coming years and, with a strong and focused leadership, we are ready for the challenge.

# **Executive Director's Report**



It is my continued pleasure to report on the operations of the Edmonton Social Planning Council for 2012. ESPC staff was involved in many work activities this past year and my remarks will only hit some of the highlights.

It was an interesting year to say the least from the perspective of social policy development. In mid spring the Provincial Government started on a journey to gather input from Albertans to help design a social policy framework that would inform

priority setting and decision-making to address social challenges.

## **Executive Director's Report—Cont'd**

Our staff met the challenge and held 8 focused discussions with over 100 individuals living in low income situations. With the assistance of ESPC volunteers we gathered participants' input, told in their words, and submitted 8 separate reports to government.

Following in a similar vein, ESPC was one of a number of organizations instrumental in providing a compelling argument for city council to embark on the development of a poverty elimination strategy for Edmonton. In 2010, data from Statistics Canada showed that 120,000, or 10%, of individuals in the Edmonton census metropolitan area were living in low income. Co-chaired by the United Way of the Alberta Capital Region and the City of Edmonton, ESPC continue to be involved in the work of developing a coordinated, place based approach to addressing poverty issues. Looking forward, we are very excited to see how this work at the local level will complement the work now underway on the Provincial Poverty Reduction Strategy, knowing that the Premier has established the goal to end child poverty within 5 years.

The issue of homelessness continued to keep our staff busy in 2012 from a number of angles. We continued to monitor progress on the 10 Year Plan to End Homelessness. We also, once again, completed research and prepared the Edmonton Homeless Commission yearly update, and were actively involved in the Homeless Count and Homeless Connect events.

Along the same lines, we were fortunate to partner with the Edmonton Coalition on Housing and Homelessness to do a community research project titled <u>Understanding Tenancy Failures and Successes</u>. Hearing for some time that several community organizations were concerned about clients who were successfully housed but later returned to homelessness, and the recurring need to find new accommodations for these clients, we conducted a research project that involved an in-depth examination of the challenge of housing retention.

In 2012, ESPC once again hosted a number of discussions amongst community members through our Lunch and Learn series established in 2010 in partnership with the Stanley Milner Library. Looking back, I am struck by the diversity of topics that were covered by our guest speakers: Literacy, racism, public safety, elder abuse, the labour movment, and particular forms of violence again women.

ESPC produced many factsheets and newsletters, prepared and distributed monthly research reviews, and continued to produce our annual Alberta child poverty report card, <u>Achieving the Promise: Ending Poverty in Alberta</u>, in partnership with Public Interest Alberta and the Alberta College of Social Workers.


So far, I have only scratched the surface of the tasks and projects we were able to accomplish over this past year. I would encourage readers to look further into this report for greater details.

As always, I want to acknowledge the work of ESPC staff. It continues to amaze me that a team of 5 people can accomplish so much. It is obvious that their passion for the issues, combined with the desire to see change, is what drives their work.

Our Board of Directors and volunteers continued to perform stellar work this year. Whether it was attending board meetings, working on subcommittees, providing input to our report or writing articles for our publications, I am always encouraged to see individuals give freely of their time and contribute to their community by putting their mark on the work of ESPC.

Finally, my thanks again goes to the ESPC members and our major funders, including the United Way of the Alberta Capital Region, the Edmonton Community Foundation, and the City of Edmonton. It's one thing to have the passion and desire to make change, but icontinued financial support is required for success.

# **Ad Hoc Advocacy Committee Report**



The Board has reached a consensus that it should be more active in advocacy. Accordingly, the Ad Hoc Advocacy Committee drafted an Advocacy Policy in 2012, which the Board amended and adopted in February, 2013. The Board then converted the Ad Hoc Committee into the Standing Advocacy Committee.

Our new Advocacy Policy recognizes that advocacy always has been part of the ESPC mission and operations, and affirms that it will continue to be. The direction of advocacy will be the responsibility of the Board, consistent with the ESPC Strategic Plan, Bylaws, Policy and

government regulations, and will be informed by advice from the Executive Director. Advocacy activities normally will be executed by the Executive Director or delegated Staff but may be executed by the Board President or delegated Board members. The spirit of this new Advocacy Policy is to enhance the ESPC's ability to further its Mission and Strategic Plan while clarifying lines of responsibility and encouraging cooperation and collaboration among the President, Board, Executive Director and Staff.

# **Policy Committee Report**



This year the Policy Committee has focused on reviewing and revising the Council's bylaws. We connected with the local chapter of Pro Bono Students of Canada (PBSC) at the University of Alberta's Student Legal Services. A team of PBSC law student volunteers, supervised by a lawyer, thoroughly reviewed ESPC's bylaws for completeness and conformity with applicable legislation, such as the Societies Act. The Policy Committee then worked to revise the bylaws to address the recommendations of the review. The proposed revisions aim to improve the comprehensiveness, clarity and consistency of the bylaws, particularly those that outline various methods of decision making. The revised bylaws should facilitate the

smooth governance of the Council. The Policy Committee was also responsible for reviewing applications for the Award of Merit for Advocacy of Social Justice.

# **Finance Committee Report**



The Edmonton Social Planning Council proposed a balanced budget for our fiscal year, which runs from January through December. In 2012, with posted revenue of \$374,780.00 and expenses of \$373,832.00 we actually achieved a very small surplus.

Just over half of the ESPC's revenue comes from the United Way of the Alberta Capital Region, with whom we continue to partner both directly and indirectly. The ESPC has been a member agency of the United Way since inception.

The Council has continued to do volunteer casinos, and on an annualized basis, these revenues represent around 10% of our budget. In 2012, the Council also obtained over \$6,000 in revenue from our first multi-agency Care with Flair Fashion Show.

Council Executive Director Susan Morrissey has continued to successfully pursue and capture several fee-for-service contracts. Complex bookkeeping continues to be undertaken by our contract bookkeeper Don McFarlane.

Our 2012 audited financial report will be presented to the AGM by Peterson Walker LLP, and is available to members on request.



# **2012 Major Publications**

# Achieving the Promise: Ending Poverty in Alberta November 2012

The Edmonton Social Planning Council, the Alberta College of Social Workers, and Public Interest Alberta released a report on current poverty trends in Alberta titled *Achieving the Promise: Ending Poverty in Alberta*. Using the latest available data, the report revealed that 91,000 Alberta children lived below Statistics Canada's low-income measure in 2009. The document also offered solutions to alleviating poverty in Alberta.





# **Edmonton Social Research Directory: 2012 Edition** September 2012

The Edmonton Social Planning Council began publishing the Social Research Directory in the 1980s. This guide was created to provide information about library collections of interest to social researchers in our community. While the ESPC hoped to update the Directory biannually, publication halted in 1989. The Social Research Directory was resurrected in 2010 and was updated in 2012.

This year's directory contains information about 28 public, academic and special libraries, archives and information

centres, the latest addition being the APIRG Resource Library.

# The role of stakeholders in integrating skilled immigrants into the workforce



## www.threesource.ca



threeSOURCE is a research database that is freely accessible to the public and is managed by the Resource Coordinator. It serves as an access

point for social research reports produced by the third sector in Alberta and in other parts of Canada. In 2012, 129 print and digital publications were catalogued in this database.

From January 1<sup>st</sup> to December 31<sup>st</sup>, 2012, threeSOURCE was accessed 1,637 times by 1,189 visitors. Users accessed 5,520 pages in the database, accessing an average of 3.19 pages per visit. In 2012, threeSOURCE received 15% more visits, 27% more visitors and 6% more page views than it did in 2011. Individuals that relied on threeSOURCE to retrieve information included employees who work in local and provincial levels of government, the province's health care sector, universities, organizations in the social services sector, and the general public.

## **Research Update Newsletter**

The monthly Research Update newsletter contains reviews of research publications that focus on important social issues that are of interest to Edmontonians and Albertans. These reviews are written by our volunteers. In 2012, 10 Research Update e-newsletters were released. The newsletter was primarily sent to Albertans who work in local and provincial levels of government, universities and colleges, individuals who work in the local social services sector and to the general public.

## **Research Services**

In 2012, the ESPC received 16 research requests for information on a variety of social issues. These requests for information came from social activists and employees of local social agencies, other non-profit organizations, and municipal and provincial levels of government. Examples of topics that these individuals and organizations requested information about included poverty trends in Alberta, family violence reduction programs and services, the impact of wet shelters, social issues that impact seniors, and immigration trends in Edmonton. Organizations who requested this information requested it to develop a better understanding of the clients they serve, to educate the public about particular social issues in our community, and develop programs and other initiatives to improve the wellbeing of disadvantaged groups in our community.

# **2012 Members Survey Summary**



The annual ESPC member's survey was conducted from January 17 to January 31, 2013. The survey was sent to 112 member emails addresses which were drawn from the Vertical Response list-serve. To increase response rate, mail merge was used to personalize the survey invite to each member. Relative to past


member surveys, the response rate was high with 48 survey participants (42.9%).

The reason most respondents state for becoming members is to stay informed about social issues (79.2%), followed by a desire to support the Council's work (68.8%). The majority (83.0%) read ESPC's publications and also visit our website (51.5%). 91.7% of respondents agreed that the ESPC's work supports their own work and interests.


The majority of respondents were either satisfied (45.7%) or very satisfied (28.3%) with the value of their membership. Some expressed an interest in being a more active member in the organization, such as through committee work or volunteering. Since some ESPC events are held at variable times throughout the year, the ability to webcast events was suggested to increase accessibility.

50.0% of respondents were satisfied and 18.8% were very satisfied that the ESPC was effectively meeting its mission. When asked to elaborate on how ESPC could increase its effectiveness, suggestions included increasing media exposure and collaboration with community partners, acting as a consultant with community based organizations, or acting more as a leader in the community on policy issues.


Question 1: What is your primary reason for being a member of the Edmonton Social Planning Council? (Choose all that apply)



Question 2: How do you stay informed about he ESPC's work? (Choose all that apply)




Question 3: How does the ESPC support your work or interest in social issues? (Choose all that apply)









Members were asked an open-ended question about what they believed could increase the value of their membership. There were 26 responses (a rate of 54.2%). The qualitative responses to this question can be roughly divided between a desire for greater involvement/interaction, suggestions, positive comments, and neutral observations.

An optional question sought suggestions in how to increase the Council's effectiveness. The way the question was framed invited a more critical assessment of the ESPC. There were fifteen responses. The proposed ideas can be divided into five areas: advocacy, collaboration, recruitment, neutral comments, and positive assessments.

## Question 8: Do you have any additional feedback?

The last optional question asked for any additional feedback. It had 6 responses divided between **positive feedback** and **reaffirmations** of what was said earlier in the survey concerning involvement and supporting initiatives.

#### 6. Operations Report

Susan Morrissey, Executive Director, reflected on the work of the Council and change within our community, province and federal level of government.

The ESPC fought really hard, around the long form census, met with our MP Laurie Hawn as well, and tried to convince the government of the importance of the long form census however was not successful in that.

Major cuts are made every day, we understand and appreciate that budgets must be balanced however the federal budget cuts seems on side of the vulnerable and those who speak for the vulnerable.

The National Council of Welfare that we have relied on has been eliminated from the

budget. Major cuts have been made to the research arm of the status of women in Canada, and an increase in old age security eligibility.

Change is also relevant with a prominent Alberta Wildrose Alliance in the legislature.

We are into year 4 of the 10 year provincial plan to end Homelessness. We are carefully tracking the numbers and being a watch dog to the government.

Premier Redford has promised to end Child poverty within 5 years. This was welcomed news and the ESPC will be closely following the efforts made and the work being done by the provincial government.

We also have coordination with street Outreach programs.

Poverty Reduction Strategy is finally under discussion within our government.

Susan Morrissey thanked the staff, and the board of directors.

Susan Morrissey also thanked our volunteer program research volunteers.

Susan Morrissey thanks our major funders the Edmonton Community Foundation, The United Way of the Alberta Capital Region, The City of Edmonton and also the ESPC members.

Susan Morrissey introduced Sabrina Sperber.

Sabrina introduced herself. Thanked Susan Morrissey for her work with the ESPC this year. Sabrina Sperber went on to introduce the upcoming Fall Fundraiser. **Answer:** Upon first receiving the Grant it would remain the same dollar amount for several years. The Edmonton Community Foundation did state that upon review the Grant amount would be reduced or eliminated completely. We gladly accepted a reduced amount for 3 years. This was determined by the funder.

**Question:** Social return from a project in 2010 was about \$21, 000 expensed but there was no funds in the budget for it.

**Answer:** The money comes in after the budget was approved. The project was under Foundation Grant the revenue and expenses match.
