## 4.0 Executive Director's Monthly Operations Report

ED reported on September 2022 operations, explaining the operations report, and sharing updates on projects

QUESTION: About the age-friendly report – are there analogous toolkits for other populations?

ANSWER: This toolkit is broad-based, covering various groups. It covers seniors but various groups of seniors.

**QUESTION**: What kind of connections and opportunities come from the RECOVER project?

ANSWER: They came to us based on the social well-being tracker, we are in a learning partnership with RECOVER, working towards a better set of descriptors and social proxies based on what Edmonton looks like in the area of social engagement.

ED brought forward information on a potential fundraising opportunity from the Oilers Foundation, and a discussion followed regarding the opinion of the board and the opportunities this could provide

**QUESTION**: What were the thoughts previously against the idea?

ANSWER: Board member agreed that it could be seen in that way, but it was also recognized that we currently do a casino every two years.

A discussion followed on office updates, looking at the options with our broker and the importance of accessibility of the office

QUESTION: In addition to elevator accessibility, what other accessibility what taken into consideration?

ANSWER: We looked at transit accessibility, increased security, and being in the downtown area

One board member indicated that having greater accessibility via an elevator may mean that our hiring and volunteer base option could increase.

ED discussed the United Way campaign and our fundraising events inviting board members to also contribute to our campaign by either donating funds, baking and or purchasing baked goods and contributing to our bottle drive. More information to follow.
